TERMS AND CONDITIONS

Membership Application Form to be completed by member.
All memberships are subject to management approval.
Membership can be frozen once a year for 30 consecutive days.
Block out dates applies on F&B discount.
Guests passes are subject to availability.
Terms and Conditions apply.

1) DEFINITIONS AND INTERPRETATION

For the purpose of these terms and conditions the following expressions shall bear the meanings assigned to them below:

- a. "Pool and Beach" means Sal Pool and Beach on Saadiyat, Jumeirah at Saadiyat Island Resort, Abu Dhabi, United Arab Emirates.
- b. "Membership Start Date" means the date the Member's application for Membership has been accepted by the Gym as per Schedule.
- c. "Manager" means the Manager of Sal.
- d. "Member" means the person whose name is on the Schedule who hereby agrees to become a Member of "Sal Pool and Beach" as per the terms and conditions hereunder.
- e. "Membership" means the Member's Membership of the Pool and Beach as per the terms and conditions hereunder.
- f. "Membership Fee" means the total fee or instalment fee amount.
- g. "Monthly Fee" means the monthly Membership subscription fee as set out on the Schedule.
- h. "Proprietor" means Sal Beach Club in Jumeirah at Saadiyat Island Resort.
- i. "Schedule" means the attached schedule of Membership details.

2) ACCEPTANCE AS A MEMBER

- a. The Proprietor has absolute discretion as to whether to accept any application for Membership. If an application for Membership is accepted by the Proprietor, Membership shall commence on the Membership Start Date.
- b. Acceptance by the Proprietor of an application for Membership shall constitute a binding contractual arrangement between the Proprietor and the Member upon these terms and conditions.

3) LIMITATION OF LIABILITY

- a. Neither Of us, our employees, agents or subcontractors will be liable to you for any loss, damage or theft of any property brought on to our premises;
or any death, personal injury or illness occurring on or resulting from use of our premises (including that caused by use of facilities and/or equipment unless caused by our employees, agent or subcontractors negligent act.)
- b. You are solely responsible for ensuring that you correctly operate or use any facilities and/or equipment which we provide.
- c. Some areas of our Pool and Beach are unsupervised at times. We do not accept responsibility for any harm or injury to you whilst using them, unless caused by our employee's, agents or subcontractors or our negligent act or omission.
- d. You will not abuse the facilities or equipment of the Sal Pool and Beach and you will pay for any damage to our property where you wilfully or negligently (including in relation to 3b) cause such damage.

4) PHYSICAL CONDITION OF MEMBER

- a. The Member warrants and represents that she/he is in good physical condition and that she/he is capable to swim or enter the pool water/sea and such action

would not be detrimental to her health, safety, comfort or physical condition.

- b. The Member is obliged to provide and underwrite any health issues prior to agreement, and these should be accurate and a true reflection of the candidate's health condition.

5) ASSIGNMENT

- a) Membership of the Sal Pool and Beach is personal to the Member. Any assignment, transfer or other disposal of Membership is at the sole discretion of Sal Manager (subject to transfer fee). The Member shall not loan her/his Membership card to any other person or permit it to be used by anyone other than the Member.

6) CONSTITUTION

- a) The Pool and Beach is a proprietary owned by the Proprietor.

7) MEMBERSHIP TERMS

- a. All Members are required to abide and adhere to SAL Pool and Beach Rules and Regulations.

Such Sal Rules and Regulations are outlined in this document. A copy of such is available to all Members upon request.

- b. If Membership fees remain unpaid, the Proprietor may charge administration fees, suspend or cancel the Membership.
- c. If Membership fees are increased, this will not affect active Memberships until time of renewal.
- d. If Membership terms materially change, the Member will be asked to review and sign a new contract.
- e. A Member may upgrade at any given point if the difference between the Membership fees is paid.
- f. Downgrade in Membership may be granted at the sole discretion of Sal. Any paid fees are non-refundable.
- g. Any Member changing Membership type during an active Membership must complete the remaining period of Membership.
- h. For Couple Membership Only - Must provide proof of partnership or family relationship.
- i. Spa treatment, Gym access and use of Spa facilities subject only to Member use. (blackout date applies)
- j. Acceptance or rejection, cancellation of membership and freezing the status of a member is on sole discretion of Sal Management and may occur if the Member is not following the rules and regulations of Pool and Beach. Such regulations may change without prior notice, and it is the responsibility of the Member to be updated and the Management to post any changes in to accessible areas and channels.

8) CHARGES FOR SERVICES

- a. All services and products outside of the Pool and Beach Membership allowance, such as Restaurant reservations and access, should be covered as normal and in full unless a Manager of Sal approves otherwise. No discount can be transferred to Restaurant premises/ offerings.
- b. Payments will be taken on the day of instruction/ purchase of your Membership / renewal.
- c. Unused services or credit cannot be refunded or transferred.
